INTRODUCTIONS

Chris welcomed committee members to the meeting and attendance was taken.

REVIEW AGENDA & ADDITIONS

No additions to the meeting agenda were requested.

APPROVAL OF PREVIOUS MEETING MINUTES

The May 13th minutes were included in the meeting materials and approved by consensus.

Chris noted that although he intends to seek clarification from MDHHS regarding any requirements to check the National Practitioner Data Bank (NPDB), he is going to wait until he receives the HSAG Compliance Examination report (expected September 4th). At the time of recredentialing, the NPDB is used to check civil judgements and settlements related to healthcare. NPDB search findings are proprietary to the organization conducting the search.

PRIOR ACTION ITEMS

Set Up a Demo for Universal Credentialing/Email Leads About Providers Credentialed Out of Region

Chris conducted a demonstration of the Universal Credentialing CRM during the regional Provider Network training on June 2nd.

Review List of Directory Services

HSAG recommended that a list of the services included in regional directories be developed to ensure continuity of terms and listings across the region. A proposed list of service types was included in the May meeting materials. The types of Long Term Supports and Services listed came from the statewide PCE Grievance and Appeal workgroup, which were adopted by the regional Quality and Compliance Oversight Committee (QOC) as part of the NMRE's FY25 Quality Assessment and Performance Improvement Program (QAPIP). Chris asked the CMHSPs to review the List of Services prior to today's meeting. No objections were noted.

OUT-OF-REGION SUBSCRIPTION MODEL IN THE UNIVERSAL CREDENTIALING CRM

During the May meeting, Kacey asked whether anyone has been able to subscribe to the credentialing of other agencies.

Chris opened the Universal Credentialing CRM and selected the PSV that was created by another agency, then selected Actions → Subscribe → Next. The next window reads, "Please download the Quality Checklist template and upload a completed copy." Although the other agency already provided a completed Quality Checklist, this step cannot be bypassed. Chris agreed to seek clarification from MDHHS regarding the need for this step.

FY26 MENTAL HEALTH BOILERPLATES

Chip sent the proposed FY26 Boilerplates to Chris, which he has shared in the Teams folders. Added language for FY26 is displayed in red print. The CMHSPs were given the authority to use the boilerplates for their FY26 contracts.

UNIVERSAL CREDENTIALING

This topic was discussed under the "Out-of-Region Subscription Model in the Universal Credentialing CRM" Agenda item.

A Universal Credentialing subgroup kickoff meeting is scheduled for June 24th at 2:00PM.

FY25 Q1/Q2 Credentialing Report

The Credentialing Report for Quarters 1 and 2 of FY25 was submitted to MDHHS by the May 15th due date.

CHECK IN – PROVIDER DIRECTORIES (HSAG 2024)

Machine Readability (HSAG 2024, SI, E20) & Organized by County (HSAG 2024, SI E 18)

Chris reviewed the machine readability of the CMHSPs Provider Directories during the meeting. Centra Wellness, Northeast Michigan, Northern Lakes, and Wellvance are all set. Some updates for physical accommodations, linguistic capabilities/cultural competency, etc. are needed for North Country. A csv version also needs to be uploaded.

Kacey asked whether there is a standard that requires providers' hours of operation to be listed on the Provider Directory. Chris responded that hours of operation are not required based on the HSAG Compliance Review Provider Directory Checklist and 42 CRF 438.10(h)(1-2).

HOSPITALS

Havenwyck Partial Hospitalization Address Change

Henry Ford Acadia Kingswood Joint Venture

Henry Ford Acadia is awaiting CMS approval. The facility may be used for general fund clients.

StoneCrest ORR Investigation – Unsubstantiated

Pat reported an ongoing rights investigation at BCA StoneCrest Center during the May meeting. The investigation was unsubstantiated and Centra Wellness has resumed admissions.

Invalid NPIs

Chris receives quarterly notifications that the Psych HRA Erroneous Invalid NPI files and Standard Invalid NPI files have been sent through the File Transfer Application. Chris then downloads the report and reaches out to the CMHSPs to correct the incorrect/invalid NPI numbers.

HCBS UPDATE

The MDHHS HCBS Leads Group is currently remediating surveys. The NMRE did not have information in its system to show which CMHSPs participate with Montgomery's, Rathbone, and Texas Manor AFC. Kim noted that Montgomery's was previously remediated.

Good morning, Universal Credentialing Admins,

We recently discovered a bug in the BH CRM system that resulted in the failure to categorize expired Universal Credentialing (UC) documentation. Therefore, UC profile statuses did not update to a status of “Expired Documentation” and no email notification was sent to the UC Provider contacts or the RCC Admins.

We will be implementing a fix on Wednesday July 2, which will move any expired UC documents and profiles to an expired status. This will result in receiving multiple emails indicating that profiles have expired documentation at midnight on 7/3. These emails are not being sent in error, they are accurate and legit. The providers will also be receiving notifications of any expired documentation.

This is Neuropsychiatric Hospital (Indiana) owned. Justin Donato is contact; correspondence from FY2024 (last year) indicates a rate of \$975 for adults and \$1150 for adults with IDD. I have requested clarification on how they would be billed, with a modifier? No contracts were made for FY2025. For FY2026, NMRE was provided codes of 0124 and 0114 (semi private and private inpatient) at \$1400, but nothing for our standard 0100 for all inclusive room and board. NMRE has requested clarification on if they would bill 0100, and if this rate would be similar to the rate provided last year, or if they do not plan to bill 0100 at all. More to come pending the hospital's response.
